0000 - Initial Comments

Two unannounced licensure complaint surveys, CCR# 2017010359 and CCR# 2017011357 were conducted on at Brookdale Willow Wood, License #7288. The facility had a deficiency found during the time of the survey.

0152 - Physical Plant - Safe Living Environ/Other - 58A-5.023(3) FAC

Based on observation and interview, the facility failed to maintain a safe living environment and ensure that it was maintained free of accident hazards for all residents living in the facility.

The findings included:

During the environmental tour of the facility on the first and third floors, on starting at approximately 11:00 AM, the following issues were identified.

 On the first floor, the carpeting in the lobby and the hallways was observed to be stained, faded, worn and stretched and rippled in the high trafficked areas.

Multiple areas of the carpeting was stretched out and created an uneven surface for the elderly residents who are unsteady on their feet and many use walkers and wheelchairs, and can pose a dangerous /accident hazard. The carpeting in the hallway outside of the physical also

observed to be stretched out and uneven.

- During the tour of the third floor, the faded and worn carpeting on all of the three hallways were observed to have multiple blackened and bleached out stains:
- a. There were food spills on the hallway carpeting outside of .
- The hallway carpeting outside of there was a 6 inch round black stain.
- c. Between 345 and 346 there was a one foot sized round blackened stain on the carpeting.
- d. Outside of , there was a three foot long off-white stain. Nearby, there was another greater than seven feet long, off-white discoloration on the red carpeting.
- e. Outside of there was an off-white discoloration about three feet long.
